## Pre-import

1. The material must be packed in sealed containers.
2. All inner and outer packaging must be swabbed with suitable disinfectant before leaving the exporting address.
3. The packaging must be clearly labelled to indicate the general licence number under which the material is imported. The label should also state that the material is for importation into GB for laboratory use for research or diagnostic purposes at a facility authorised to handle and store the imported pathogen or carrier.
4. Irrespective of the mode of transport, all specimens must be packaged so that they fully comply with the requirements of relevant Post Office or International Air Transport Association (IATA) regulations.
5. You must inform **Centre of International Trade Carlisle (CITC)** if you intend to use this General Licence by completing an Importer Notification Form for Part 1, Schedule 1, Specified Animal Pathogens (AP05) available on GOV.UK and emailing it to the Imports Team at least one working day prior to importation. Please use IV69(E) as your email subject heading, attaching a copy of any applicable licence made under one of the SAPO Orders.

## Post-import

6. The material must remain in its original wrapping at all times and be taken directly to the destination premises.
7. At all times during transit and on its arrival at its final destination the pathogen must be handled in accordance with any relevant conditions contained in any applicable licence made under one of the SAPO Orders.

## Notes

This licence is granted under animal health legislation and gives no exemption from any prohibition, regulation or restriction imposed by any other Government Department or Agency.

Only laboratories listed in Commission Implementing Decision (EU) 2018/1099 of 1 August 2018 are authorised to handle live Foot and Mouth Disease (FMD) virus.
